The type of personal information we collect

We currently collect and process the following information as part of our various activities:

- Personal identifiers, contacts and characteristics (for example, name, contact details, date of birth etc).
- Employment/personnel records and recruitment information.
- Copies of ID, bank account details, payment records and tax status information.

We may also collect, store and use the following ‘special categories’ of more sensitive personal information:

- Information about race or ethnicity, religious beliefs, sexual orientation and political opinions.
- Information about criminal convictions and offences.
- Information about health, including any medical condition, health, and sickness records.
- Trade union membership.

How we get the personal information and why we have it

Most of the personal information we process is provided to us directly by you for one of the following reasons:

- Applying for or awarded grants or services from The Fore.
- Providing funding to or partnering with The Fore.
- Subscribing to our newsletters and networks.
- Registering/attending a workshop or event.
- Responding to a survey, giving feedback or contacting us.
- Applying for a role or recruited to work or volunteer with The Fore.

We also receive personal information indirectly, from third parties or publicly available sources, for example:

- Previous employers/referees.
- Background check agencies.
- Publicly available sources such as Companies House, websites etc.
- Third party online platforms such as Eventbrite and Calendly which are used to help us provide services.

We use the information that you have given us in order to:

- Perform the contract we have entered into with you.
- Provide services.
- Comply with a legal obligation.

We may share personal information with third parties where it is necessary to administer the working relationship, where it is required by law, or where we have another legitimate interest in doing so. For example, third parties, including third-party service providers, could include IT support services and accountants. All our third-party service providers are required to take appropriate security measures to protect your personal information and we do not allow them to use your personal data for their own purposes. We only permit them to process your personal data for specified purposes and in accordance with our instructions.

Under the UK General Data Protection Regulation (UK GDPR), the lawful bases we rely on for processing this information are:

- a) Your consent. You are able to remove your consent at any time. You can do this by contacting info@thefore.org
- b) We have a contractual obligation
- c) We have a legal obligation
- d) We have a vital interest
- e) We need it to perform a public task
- f) We have a legitimate interest

How we store your personal information

Your information is stored securely and we limit access to your personal information to employees and other third parties who have a business need to know. They will only process your personal information on our instructions and they are subject to a duty of confidentiality.

We will only retain your personal information for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting or reporting requirements. To determine the appropriate retention period for personal data, we consider:

- the amount, nature and sensitivity of the personal data;
- the potential risk of harm from unauthorised use or disclosure of your personal data;
- the purposes for which we process your personal data and whether we can achieve those purposes through other means;
- the applicable legal requirements.

In some circumstances we may anonymise your personal information so that it can no longer be associated with you, in which case we may use such information without further notice to you.

Impact measurement tool with Pro Bono Economics

We are working in partnership with Pro Bono Economics, registered charity number 1130567, to deliver an impact measurement tool and conduct data analysis to assess the changes in

wellbeing among the beneficiaries of charities funded by us, while also supporting economic evaluations for both the funded charities and The Fore as a whole (The Project).

If you are a beneficiary of one of these funded charities, the charity may provide you with a link to an online survey to fill in as part of The Project. If you respond to the survey, we may collect the personal information listed in the section titled 'The type of personal information we collect', including 'special categories' information. We and Pro Bono Economics will use that information for the purposes of The Project, but only where you have consented for each of us to do so. If you do not consent, we will not be able to use your data as part of The Project. You have the right at any time to withdraw your consent once given.

Where we process your personal information in connection with The Project, both we and Pro Bono Economics will be joint controllers of your personal information. This means that both of us work together to decide why and how your personal information is processed in connection with The Project. Your personal information will be shared between us and Pro Bono Economics for the purposes of The Project. The Fore will be responsible for the collection and hosting of your personal information. Pro Bono Economics will be responsible for carrying out data analytics, however, we usually only carry out data analytics where we have anonymised your personal information first (meaning you will not be identified from the information so that it will no longer be considered personal information under the GDPR). You have rights with respect to your personal information. These are detailed in the 'Your data protection rights' section below. Where you consent, we will also share your personal information collected through the online survey with the charity that provided you with a link to that survey. Please read the privacy policy of the charity (service provider) that shared the survey link with you to understand how they may process your personal information.

Your data protection rights

Under data protection law, you have rights including:

- **Your right of access.** You have the right to ask us for copies of your personal information.
- **Your right to rectification.** You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.
- **Your right to erasure.** You have the right to ask us to erase your personal information in certain circumstances.
- **Your right to restriction of processing.** You have the right to ask us to restrict the processing of your personal information in certain circumstances.
- **Your right to object to processing.** You have the right to object to the processing of

your personal information in certain circumstances.

- **Your right to data portability.** You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
